Empanelment of Maharashtra Based Training Providers

**to impart Skill Development Training Programs under various schemes in Maharashtra aiming to
“Empowerment of Women, Livelihood Enhancement of Youth from SC communities in Maharashtra”**

Apparel, Made-Ups & Home Furnishing Sector Skill Council (AMHSSC), a sector Skill Council for Apparel, Made-Ups & Home Furnishing sector invites proposals from Maharashtra Based Training Providers/Centers for empanelment with AMHSSC for providing domain skilling and providing wage/self-employment opportunities under Short Term Training (STT) model aiming to “Empowerment of Women, Livelihood Enhancement of Youth from SC communities in Maharashtra.

The ultimate goal under this STT initiative is to build skilled work force to cater to the specific job requirements of Apparel, Made-Ups & Home Furnishing sector under the national mission of Skill India. The Organizations/Industry Association can directly partner with AMHSSC and can build skilled work force as per their domain requirement for meeting their needs.

The salient features of the STT program under Project:

- Projects have the provision of train the candidates under the Job Roles of Apparel, Made-Ups & Home Furnishing Sector and providing the placements/self-employment opportunities to candidates under the said sector. For the specific purpose of STT model, employment will mean wage employment/Entrepreneurship opportunities.
- The candidate enrolment should be as per the capacity of the Training Centre on the relevant online portal and E-KYC would be done for the candidates.
- The Skill Training will be conducted as per the demand generated from Apparel, Made-Ups & Home Furnishing Industries.
- Post completion of the skill training, AMHSSC will conduct the assessment & certification of the trainees and Skill India certification will be provided to the successful candidates.
- The candidate enrolments will have to be done immediately after the work allocation (if the Training Provider is selected).

Eligibility Criteria: The Training Providers complying eligibility criteria (**Annexure – I**) may submit their proposal at nikhil.malhotra@sscamh.com latest by 14th August, 2026 in the prescribed format (**Annexure – II**) on the company letterhead with the interest to get empanelment with AMHSSC for skill training and employment in STT model.

Additionally, the Training Providers will have to provide the required information in prescribed format under **Annexure - III**

There is no fee for Training Providers to submit their Expression of Interests (Eol).

- Taking empanelment as a Training Provider with AMHSSC is mandatory for the Organization. Priority will be given to the Training Providers already affiliated with AMHSSC.
- The Organization should be operational since past 3 years.
- The Organization should be having well equipped classrooms.
- The Organization should be having valid PAN, GST.
- The proposed Training Centres (under Annexure – III) must not be pre-occupied for imparting the STT under AMHSSC or any other sector’s training program and must be available to impart the targets allocated under the Eol.
- Training Providers already working under skill training programs in Maharashtra will be given preference.

Training partners must meet the following qualifications to be considered for empanelment and are requested to submit the following information in hard copies:
